2. The Local Government Unit of Alamada now invites bids for the above Procurement Project. Delivery of the Goods is required by 8 days. Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
