Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. the 2016 revised IRR of RA No. 9184.

8. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below on or before February 26, 2024. Late bids shall not be accepted.
9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
10. Bid opening shall be on February 26, 2024 at 10:00am at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
