The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person with official receipt.

5. The Local Government Unit of Alamada will hold a Pre-Bid Conference on April 12, 2023 at 10:00 AM, BAC Office, LGU, Alamada, Cotabato which shall be open to prospective bidders.

6. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below on or before April 25, 2023 at 10:00am. Late bids shall not be accepted.

7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.

8. Bid opening shall be on April 25, 2023 at 10:00am at the given address. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
