- 3. The Local Government Unit of Alamada now invites bids for the above Procurement Project. Delivery of the Goods is required by 10 days. Bidders should have completed, within 2 years from the date of submission and receipt of

bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

A complete set of Bidding Documents may be acquired by interested Bidders on April 15, 2023 to April 25, 2023 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of P 500.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees thru cash.
- 7. The Local Government Unit of Alamada will hold no pre-bid conference.
- 8. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below on or before April 25, 2023. Late bids shall not be accepted.
- 9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 10. Bid opening shall be on April 25, 2023 at 10:00am at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
