- 5. The Local Government Unit of Alamada will hold a Pre-Bid Conference on April 26, 2023 at 10:00 AM, BAC Office, LGU, Alamada, Cotabato which shall be open to prospective bidders.
- 6. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below on or before May 09, 2023 at 10:00am. Late bids shall not be accepted.
- 7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
- 8. Bid opening shall be on May 09, 2023 at 10:00am at the given address. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
