8. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below on or before May 04, 2023. Late bids shall not be accepted.

9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

10. Bid opening shall be on May 04, 2023 at 10:00am at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
