- 2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 3. The Local Government Unit of Alamada now invites bids for the above Procurement Project. Delivery of the Goods is required by 40 days. Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees thru cash.
- 7. The Local Government Unit of Alamada will hold no pre-bid conference.
- 8. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below on or before May 04, 2023. Late bids shall not be accepted.
- 9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 10. Bid opening shall be on May 04, 2023 at 10:00am at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
