Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. 9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

10. Bid opening shall be on May 04, 2023 at 10:00am at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
