- 3. The Local Government Unit of Alamada now invites bids for the above Procurement Project. Delivery of the Goods is required by 40 days. Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. - 8. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below on or before May 04, 2023. Late bids shall not be accepted.
