- 8. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below on or before February 7, 2024. Late bids shall not be accepted.
- 9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
