- 2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 3. The Local Government Unit of Alamada now invites bids for the above Procurement Project. Delivery of the Goods is required by 60 days. Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

- 8. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below on or before February 26, 2024. Late bids shall not be accepted.
