2. Bids received in excess of the ABC shall be automatically rejected at bid opening.

3. The Local Government Unit of Alamada now invites bids for the above Procurement Project. Delivery of the Goods is required by 30 days. Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

5. Prospective Bidders may obtain further information from Local Government Unit of Alamada and inspect the Bidding Documents at the address given below during Mondays to Fridays 9:00am to 4:00pm.

10. Bid opening shall be on March 7, 2024 at 10:00am at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
