6. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below on or before March 21, 2024 at 10:00am. Late bids shall not be accepted.

7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.

8. Bid opening shall be on March 21, 2024 at 10:00am at the given address. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
