- 7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
- 8. Bid opening shall be on March 21, 2024 at 10:00am at the given address. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
